Strengthening Collaboration on the 2030 Global Biodiversity Framework (GBF)



RATIONAL

The Global Goals and Targets of 2030 GBF are well reflective of the principles of habitat restoration and nature's contributions to people through its functions and services.

Increasing wildlife numbers has been set as a priority in the 2030

GBF clearly connects this increase in wildlife populations to their sustainable use for human benefit in one of its targets

***Target 5** – Ensure that the use, harvesting and trade of wild species is sustainable, safe and legal*

Resolution: Implement conservation projects that are fully aligned with the 2030 Global Biodiversity Framework and develop a CIC 2030 Programme.

Strengthening Collaboration on One Health



RATIONAL

Areas with weak health infrastructure and late warning and response systems – primarily in developing countries – will be unable to effectively cope with new outbreaking zoonotic diseases and other livelihood challenges

Urgent need for a unified multi-sectoral approach to balance and enhance the health of people, animals and the environment

2030 Global Biodiversity Framework acknowledges the interlinkages between biodiversity and health and calls that the framework be implemented with consideration of the One Health Approach

CIC's main strength comes from its membership having a strong presence on the ground that allows for continuous surveying and monitoring of wildlife species and wildlife habitats.

Resolution: Implement conservation projects on national and local levels to enhance ecosystem resilience, and actions to halt biodiversity loss in support of the UN One Health agenda.

Establish an IPLC Working Group



RATIONAL

Lands and waters managed and conserved by indigenous peoples and local communities are among the most diverse places on earth that hold about 80% of the planet's biodiversity

Global Biodiversity Framework aims to ensure that the management and use of wild species are sustainable, providing social, economic and environmental benefits for people most dependent on biodiversity

Indigenous Peoples and Local Communities as the key stakeholders in achieving the mission of the CIC.

Resolution: Establish an intersessional CIC Working Group with representatives from Indigenous Peoples and Local Communities to consider how to effectively engage IPLCs in the global decision-making processes
